## PROPANE APPLIANCE REBATES FOR TEXAS HOMEBUYERS



For the 2022 calendar year, the Propane Council of Texas is offering Texas homebuyers propane appliance rebates for installing select new propane appliances placed into service on or after January 1, 2022.

Homebuyers will need documentation from the builder on what propane appliances are included in the home.

Texas homebuyers are not the only ones that qualify for propane appliance incentives. Our national counterpart the Propane Education & Research Council (PERC) implements a Propane Construction Incentive Program for builders and remodelers. In recent years, the program has expanded and eliminated the cap on the number of houses per builder per year.

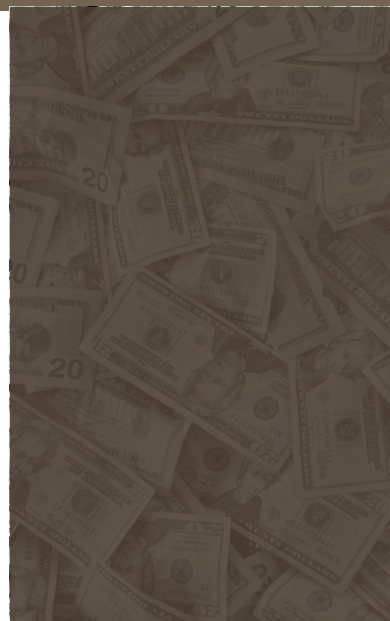
The Propane Education & Research Council will pay builders up to \$1,000 for each new home or remodel completed in 2022, if you include qualifying propane appliances. You can also earn a \$500 bonus for installing propane appliances specified for your region. That's \$1,500 per home.

### WHO CAN APPLY?

In addition to meeting the baseline propane installation requirements, you must also meet the following criteria:

- You are a U.S. builder or remodeler, and at least 18 years of age.
- The homes for which you are applying were built or remodeled in December 2021, and/or January through December 2022.

Incentive funding may be limited, so the sooner you submit your application, the better.

## HOW IT WORKS

Qualifying and selected construction professionals receive a monetary incentive for building or remodeling homes using new propane appliances.

Verification of installed appliances should be provided by a completed gas check, or similar form, performed by a propane supplier.

## EARN UP TO \$1,000 IN INCENTIVES

Propane application	Incentive
At least one of these applications is required	
Boiler, furnace, hydronic air handler, or combi boiler (not heat pump)	\$500
Water heater (tankless or storage tank)	\$300
Hybrid heat pump with propane gas emergency heat	\$300
Additional propane applications	
Cooktop or range, clothes dryer, standby generator, fireplace or gas log set, propane gas piping for outdoor equipment (must comply with all codes)	\$100 per propane appliance

## EARN A \$500 REGIONAL BONUS

In the South Central United States, which includes, Texas, you can earn an extra \$500 on top of the baseline incentive for installing a backup to air source heat pump or furnace.

## HOW TO APPLY



Visit <https://propane.com/pcip/> to learn more, determine if you qualify, apply, or reserve your incentive for a project not yet completed. As a part of the application process, you must also submit a home energy analysis from the Energy Planning Analysis Tool (EPAT) for each project in order to qualify. The EPAT is an easy to use, online tool that calculates potential energy use and modeled emissions data about your homes, which must be included with your application.

*The program will pay participants upon receiving a completed contract, W9, EPAT, and Gas Check. Applicants will receive a 1099 for tax purposes.*
